CLARK FOUNTAIN CLIENT ACHIEVES NEARLY \$11 MILLION VERDICT AGAINST CONTINENTAL TIRE

After listening to evidence presented during the course of a complex three-week trial, a Palm Beach County jury found that Continental manufactured its tire with a defect, resulting in a horrific tire-blowout on I-95 in 2009. On the afternoon of May 19, 2009, Tracey Parker was driving to her job in Port Saint Lucie, FL, when her vehicle’s right rear tire failed, causing the vehicle to roll over three times.

Trial attorneys **W. Hampton Keen, Donald R. Fountain,** and appellate attorney, **Julie H. Littky-Rubin,** contended that a defect in the tire caused it to prematurely fail without warning. At the time of its failure, Parker’s tire appeared well maintained, with no uneven tread wear, no repairs, plenty of tread depth and three years remaining on its warranty. Continental Tire, a German-owned company, denied all responsibility for the tire’s failure.

The jury awarded the 39-year-old mother of three and her husband nearly \$11 million for the catastrophic injuries she suffered. Mrs. Parker spent over a month in a coma, 102 days in the hospital and underwent 17 surgical procedures, succumbing to extensive and ongoing medical treatment.

Clark Fountain is proud to have represented and achieved justice for the Parkers after an almost four-year battle against the defendant, Continental Tire, one of the largest tire manufacturers in the world.

\$3.5 MILLION RECOVERY FOR MILD TRAUMATIC BRAIN INJURY

Mark W. Clark and Christa L. McCann represented a client who suffered a mild traumatic brain injury and multiple non-surgical orthopedic injuries as a result of an automobile accident. Following the accident, the client developed complex regional pain syndrome in the upper extremity which required a series of stellate ganglion blocks. These injuries prevented the client from returning to pre-accident employment.

Liability was vigorously contested by the defendants, however, the accident reconstruction and bio-mechanical engineer experts hired by the firm were able to scientifically establish fault on the defendant driver. As a result, Clark and McCann were able to successfully negotiate a \$3.5 million settlement shortly before trial. The client now has the funds necessary to offset the significant loss of income and to pay for future medical care.

SETTLEMENT REACHED FOR MAN LEFT PARALYZED FOLLOWING SURGERY

Attorney **Nancy La Vista** obtained a confidential settlement for a 62-year-old man who underwent elective abdominal aortic aneurysm repair. After surgery, the hospital failed to keep his blood pressure at a sufficient level to maintain blood flow to the arteries that supply the spinal cord.

As a result, he suffered a spinal cord infarction similar to a brain stroke, and was left paralyzed from the waist down. While the settlement will never give the man the use of his legs back, the efforts of Ms. La Vista have helped him to regain his freedom. The client, who was left homebound with no transportation for the last three years, recently purchased a special van with a portion of his settlement. “I feel like I have been let out of jail,” he said after the case was resolved.

SETTLEMENT REACHED FOR MAN SEVERELY INJURED BY DEFECTIVE DUMP TRUCK BRAKING SYSTEM

Our client became catastrophically injured when the park brake system in his roll-off dump truck failed, causing the truck to unintentionally come out of park and into drive. As a result, the massive truck rolled forward, pinning the client against a metal gate as he was in the process of unlocking it. The client suffered significant internal and orthopedic injuries, but miraculously survived. However, this harrowing ordeal left him with a lifetime of serious medical issues, dramatically reducing his quality of life.

Shortly after the accident, the manufacturers of the truck issued a nationwide recall for defects with the park brake system, although the recall allegedly did not involve the subject truck’s brake system. Attorneys **W. Hampton Keen, Timothy J. Murphy** and **Cyrus Niakan** collaborated in pursuit of justice for the injured client, and convinced the truck manufacturer and the park brake system component designer to settle the case prior to trial. The confidential settlement will help provide stability and support for our client’s future.

SEMI-TRACTOR LOSES CONTROL CAUSING VIOLENT COLLISION AND SEVERE INJURIES

This past month **Mark Clark** and **Christa L. McCann** obtained a confidential settlement on behalf of a client involved in a violent collision on the Florida Turnpike involving a commercial semi-tractor. The semi-tractor driver struck the driver's side of the client's vehicle, pinning her vehicle up against the Turnpike guardrail and trapping her inside her vehicle.

The defendant's truck driver contended that he lost control of the semi because of another accident on the Turnpike. As a result of the collision, the client suffered severe spinal, hand and wrist injuries that required lumbar spine surgery, hand and wrist surgery, as well as chronic pain management. Suit was filed against the defendant driver and his corporate employer. Shortly before trial, the defendant's insurance company paid a confidential settlement.

CONFIDENTIAL SETTLEMENT OBTAINED FOR TRAIN CONDUCTOR INJURED ON THE JOB

While working the night shift, a cargo train conductor descended from his train, falling on debris that had spilled from the train's cars and accumulated in the area where the railroad employees were trained to walk. The young man fell under the slowly moving train, suffering traumatic amputations to his feet, as well as a fractured pelvis, and significant neck and back injuries. He was also diagnosed with Post-Traumatic Stress Disorder caused by the terrifying mental and physical trauma he endured.

The injured man retained attorneys **David C. Prather** and **Donald R. Fountain** who pursued negligence claims against the railroad for allowing vegetation to accumulate and remain on the tracks in violation of railroad policy, and for failing to follow proper safety procedures. From the evidence adduced during the numerous depositions of both lay and expert witnesses, the firm ascertained that the railroad violated certain federal and state safety laws, which mandated safety procedures that were not followed. The work done by the firm resulted in a confidential settlement shortly before trial, providing compensation for the physical and emotional needs our client and his family will have for the rest of his life.

FAMILY OF TEEN DROWNING VICTIM REACHES SETTLEMENT WITH GROUP HOME

In 2012, attorney **David C. Prather** filed a wrongful death suit against a group home in Lake Worth involving the death of a 17-year-old mentally and emotionally disabled teenager who resided there. Even though she could not swim, the group home staff failed to properly supervise the girl, or take the proper precautions to ensure the young woman's safety during a sponsored trip to Lake Worth Beach. Left unattended, the force of the ocean currents dragged her under water, causing her to drown.

Mr. Prather confirmed the lack of supervision through the multiple depositions of the lifeguards, staff members, and independent witnesses. Prior to trial, the defendant settled for a confidential amount. While the settlement cannot bring the young victim back, it will serve as a reminder to group facilities and others to take better safety measures to prevent these kinds of tragedies.



LEGAL ALERT: DROWNING PREVENTION TIPS

Unfortunately, our firm has seen many tragic cases that involve accidental drowning. In so many cases, the injuries are preventable. According to the Centers for Disease Control, approximately 10 people die from accidental drowning every day in the U.S. Of these, two are children age 14 years and younger. Drowning ranks fifth among the leading causes of unintentional injury in the United States. Being educated and aware just might help save a life.

How can you ensure proper water safety for you, your loved ones and those around you? According to **Safekids.org**:

1 KEEP A CLOSE EYE ON YOUR KIDS

Whether you're at the pool or at the beach, it goes without saying that your children should be your first priority. If you're with a toddler or an infant, keep them within arm's reach, even if they are in the shallow end. Small children can drown in as little as one inch of water. Avoid any distractions, such as using your cell phone.

Safekids.org recommends using the Water Watcher strategy when there is more than one adult present, where one adult is designated to be the primary supervisor for at least 15 minutes at a time.

2 INTRODUCE YOUR CHILD TO THE WATER AS SOON AS POSSIBLE

Don't wait to introduce your children to the water. Lessons are available for children as young as six-months old. If you feel they're ready, teach them how to tread water, float and stay by the shore.

3 LEARN CPR

Don't rely on a lifeguard or someone else to save your child's life. Learn CPR and get recertified every two years. Have your children learn CPR too.

4 USE THE BUDDY SYSTEM

Kids should always swim with a buddy. Look for swimming areas that have lifeguards on duty whenever possible. Teach your children never to go near any body of water if an adult is not with them.

5 BE AWARE OF RIP TIDES

If you get caught in a rip tide, don't swim against the current or start to thrash. Stay calm, and swim sideways, parallel to the beach until the tide dissipates or you reach less turbulent water.

6 SWIMMING IN OPEN WATER ISN'T THE SAME AS SWIMMING IN A POOL

When you're at the beach or at the lake, kids [and adults] should only swim in approved swimming areas. Educate them on how river currents, ocean undertow and changing weather can be hazardous.

7 POOL TOYS ARE NOT THE SAME AS FLOATATION DEVICES

While water wings, inner tubes or noodles can be fun, they are not designed to prevent your child from drowning. Only life jackets can do that.

SETTLEMENT ENDS LENGTHY LITIGATION FOR AMPUTEE INJURED BY CARWASH MACHINERY

On the eve of trial, and after years of litigation, attorneys **Donald R. Fountain**, **Timothy J. Murphy** and **Cyrus Niakan** secured a confidential settlement in a product defect case for a central Florida woman, who suffered an above-the-knee leg amputation inside an automatic carwash tunnel. The client, an employee of the carwash, was walking inside the carwash tunnel when one of the rotating wash brushes suddenly made contact with a steel reinforced water hose, in turn wrapping the client between the hose and the rapidly rotating brush. The power of the machinery going awry constricted the woman's body against the brush and severed her leg.

The firm asserted that the manufacturer defectively designed the carwash equipment, and that its design and installation were both unreasonably dangerous. Their experts explained that the rotating wash brush should have automatically shut off when it encountered the resistance of the client's body – before any injury occurred. The settlement will allow the client to afford the extensive and ongoing medical care she will need from her now lifelong impairments.

SETTLEMENT REACHED IN DEATH OF REHABILITATION CENTER PATIENT

After suffering a heart attack, an 80-year-old patient was admitted to the Lexington Rehabilitation Center in St. Petersburg, Fla. for rehabilitation. Despite the fact that he was a known fall risk, once he arrived at the facility, staff members left the man unattended for approximately 10 minutes as they reviewed his paperwork.

During that time, the man stood up, fell and struck his head. He suffered a closed head injury, and sadly was removed from life support six days later. Attorney **Nancy La Vista** filed suit against the rehabilitation center on behalf of his wife of 61 years. The defendant refused all attempts to settle the claim until the trial judge granted La Vista's motion to amend the complaint to seek punitive damages.

Within days of that ruling, La Vista served Lexington with a settlement proposal, which they promptly accepted.
