FIRM WINS \$6.32 MILLION ARBITRATION AWARD AGAINST NEGLIGENT RADIATION ONCOLOGIST

Attorneys Nancy La Vista and Timothy J. Murphy won a \$6,320,000 arbitration award for clients, Belinda and Scott Burns, against radiation oncologist, Ronald Woody, M.D. Dr. Woody works for Mid-Florida Radiation Oncology, PA in association with Port St. Lucie Ventures. The verdict was rendered by Retired Judge, Leonard Fleet, in his capacity as arbitrator.

Based on expert testimony and other evidence, the arbitrator found Dr. Woody negligent in administering an overdose of radiation to treat squamous cell cancer in situ—a precursor to skin cancer—on Ms.

Burns' hands. The overdose resulted in radiation burns and radiation fibrosis causing disfigurement, and the likelihood of future amputation of one or both of her hands.

The firm's client was diagnosed with a herniated lumbar disc following a minor property damage, rear-end auto

accident and underwent a one-level discectomy and fusion surgery. The defense doctor opined that the disc injury and need for surgery was not related to the accident, but instead was the result of a pre-existing degenerative disc disease. Clark was able to establish a causal connection between the injury and surgery, and the accident in question, and obtained a \$525,000 settlement for the client.

FIRM WINS \$626,000 IN TRAGIC WRONGFUL DEATH SETTLEMENT AGAINST TRUCKING COMPANY

A 19-year-old woman who was an honor student in high school and college was travelling westbound to her job as a counselor at the Girl Scouts of Florida when she suddenly lost control of her vehicle after hitting the shoulder of the roadway. After trying to regain control of the vehicle, she ended up partially in the eastbound lane of oncoming traffic. An inexperienced truck driver who clearly saw the young woman's vehicle in his lane of travel, and had almost three football field-lengths to react, failed to apply his brakes or take any evasive action until after impact. The impact of the truck driver's collision was so significant that it killed the woman instantly.

Attorney **David C. Prather** represented the young woman's parents, who were acting as co-personal representatives of her estate. They brought suit against the truck driver and his company, as well as their insurance company, Liberty Mutual. The case settled for \$626,000, of which \$500,000 was received from the truck driver and his company.

ROLLOVER DEATH RESULTS IN SETTLEMENT AGAINST RENTAL CAR COMPANY

A removable rear passenger seat in a rental car, which was allegedly not properly locked and secured to the vehicle by the rental agent, became dislodged during a rollover crash. When the vehicle rolled over into a shallow canal and came to rest on its roof, the unsecured vehicle seat trapped a young child whose booster seat was seat-belted to the vehicle seat, causing her to drown.

Clark Fountain's products liability team successfully pursued claims against the rental car company for failing to properly secure the seat before renting the car to a consumer who was unfamiliar with the seat's various functions, and for failing to have proper safety policies in place. The attorneys also argued that the vehicle and seat manufacturer were liable for developing and implementing a faulty seat design.

\$11 MILLION APPELLATE JUDGMENT EARNS TEAM "MOST EFFECTIVE LAWYERS 2011"

that the Mitsubishi SUV's passenger seat belt and seat back were defective, causing the passenger to be partially ejected during a rollover which resulted in his death.

FIRM WINS \$352K VERDICT AFTER REJECTING \$50K PRETRIAL OFFER

Attorneys Mark W. Clark and W. Hampton Keen won a \$352,000 verdict in September 2011 for a client who sustained a tibial plateau fracture during an accident. The fracture did not require surgery at the time of the accident; however, the 65-year-old plaintiff eventually had arthroscopic surgery for cartilage damage in her knee. The defendant's insurance company, State Farm, only offered \$50,000 to settle the case before trial. Clark and Keen won the verdict, despite physician testimony for the defense that the plaintiff's arthroscopic surgery was not related to the accident, but was the result of pre-existing arthritis.
