FIRM HELPS FAMILIES OF FOUR TEENAGERS WHO DIED IN CALIF. AUTO ACCIDENT

Don Fountain, W. Hampton Keen and Poorad Razavi recently resolved a challenging vehicle defect case in California against a major automobile manufacturer. Four teenagers were tragically killed and a fifth was ejected when the vehicle they were traveling in lost control and rolled over multiple times. Razavi and Fountain asserted allegations of defective airbags, as well as a failure to implement and install side curtain airbags and proper stability control in the vehicle. The case was especially problematic as the now deceased driver was traveling nearly 90 mph when he lost control. Needless to say, all of the families of those who died were thankful to obtain a quick and favorable settlement in light of the emotional hardships they faced.

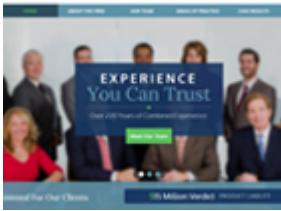

85 MILLION TAKATA AIRBAGS MAY STILL FACE RECALL



According to [Reuters](http://www.reuters.com), there are about 85 million Takata air bag inflators in the United States that would eventually need to be recalled unless the company can prove they are safe. This is the first public accounting of the total number of unrecalled Takata air bag inflators by the U.S. government. So far 28.8 million inflators have been recalled by 14 automakers. More than 100 people have been injured and 11 killed due to the defective inflators.

FAR TOO MANY RECALLED CHILDREN'S PRODUCTS REMAIN IN USE

[Chicago Sun Times](#) recently reported on the large number of recalled children's products that remain in use. Although stronger regulations have led to a record drop in dangerous children's product recalls, a review of 2014 recalls found only one percent of all recalled products purchased by consumers ended up being fixed or returned to the seller.



ABA OPPOSES SWITCH TO ACCRUAL ACCOUNTING

ABA President Paulette Brown announced the organization's opposition to proposals that would require law firms with annual gross receipts over \$10 million to use the accrual method of accounting, according to [ABA Journal](#). Currently law firms and personal service businesses are allowed to use the cash method of accounting, in which income is not recognized until cash or other payment is actually received. However, with the accrual method, many law firms would be forced to pay taxes on income they haven't received and may never receive.

TESLA RECALLS 2,700 SUVs



According to [CNBC](#), Tesla is issuing a voluntary recall for 2,700 Model X SUVs. Following a crash test, the company discovered that the third-row seat backs could collapse forward in some accidents. The seat backs were provided by an outside supplier, Futuris.

OVER 11,000 HONDA ACCORDS RECALLED

[Fortune](#) recently reported that Honda is recalling more than 11,000 Accord Sedans, some of them for the fifth time since 2014. The recall covers 2004 to 2007 Honda Accords. Honda dealers have discovered that the wrong Takata air bag inflators were installed in some of the vehicles. The incorrect inflators were designed for South American vehicles and do not comply with U.S. vehicle safety regulations.

HYUNDAI RECALLS 173,000 SONATAS



Hyundai is recalling about 173,000 Sonata sedans in model year 2011, according to [USA Today](#). The recall is due to a glitch that could cause loss of power steering, potentially leading to a crash. According to Hyundai, the electronic power steering circuit board can become damaged, leading to the loss of power steering.

PILGRIM'S PRIDE CHICKEN NUGGETS RECALLED

Waco, Texas-based Pilgrim's Pride is recalling approximately 40,780 pounds of fully cooked chicken nugget product, according to [Consumer Affairs](#). The products, which were produced on October 5, 2015, may be contaminated with extraneous plastic materials. They were labeled as "GOLD KIST FARMS Fully Cooked Whole Grain Popcorn Style Chicken Patty Fritters" and were distributed to 13 states, including Florida.
