Case Resolutions

Confidential Settlement Reached in Commercial Trucking Accident Resulting in Multiple Surgeries, Total Knee Replacement

While driving on I-75 in Nokomis, Florida, our client was struck by a commercial truck and sustained severe injuries that required multiple surgeries to her shoulder and knee, including a total knee replacement. The truck lost control after a tire blowout and struck the right side of our client's vehicle, dragging it to the shoulder of the interstate and causing it to crash head-on into a guardrail.

Partner David C. Prather filed suit alleging the well-known national trucking company was negligent in the maintenance of the company vehicle, stating the tire blowout was a result of improper inspection and maintenance, which ultimately led to the defective condition of the tire at the time of the accident. Prather successfully resolved the case before trial for a significant amount. The settlement will compensate our client's medical expenses, as well as any treatment she will need in the future. It will also compensate her for the mental anguish she suffered as a result of the accident.



The evidence showed the truck driver was on his cell phone at the time of the crash, but the jury ultimately determined that the other driver was 100% responsible for killing the plaintiff's husband.

During the jury selection process, the plaintiff tried to use a peremptory strike on an African- American female juror, who candidly advised that she had been married to a tractor-trailer driver for over thirty years. Plaintiff's counsel sought to strike the juror from serving, concerned that her relationship with her husband and the challenges he faced would lead to possible bias. However, because the defendant truck driver was also African-American, the trial judge denied the peremptory strike, refusing to find the fact that the potential juror had been married to a tractor-trailer driver for over thirty years was a "race-neutral" reason to exclude her, and finding that she would be the only African-American person to serve on the jury.

Notwithstanding the almost three-week trial, Ms. Littky-Rubin, along with trial counsel from the referring law firm, convinced the trial judge that he had made a mistake, resulting in the grant of a new trial. As the trial judge wrote in his Order granting the new trial:

It is not easy for a court to have the Appellate Court rule against it, much less for the Court to rule against itself; but justice is a far greater taskmaster than the Court being right.

The matter is currently on appeal, and the plaintiffs are hopeful that a new trial without a potentially biased juror will yield a very different result.

Porsche Recalls 100,000 Vehicles Over Rollaway Concerns

Audi Recalls 265,000 Vehicles to Fix Airbag, Wheel Trim

Several popular models are being recalled in the U.S. for a faulty electrical connection that can deactivate the passenger airbag. The same vehicles feature wheel trim that can fall off and become a hazard on the road.



Mazda3 Recalled for Loose Lug Nuts



More than 25,000 2019 Mazda3 vehicles are being recalled because the lug nuts that hold the wheels in place may not have been properly tightened. The manufacturing error creates the potential for the wheels to fall off when the

vehicle is in motion.

Honda Recalls 1.6 million Vehicles Over Takata Airbags

According to a recent statement, Honda is ahead of the NHTSA's schedule for replacing defective Takata airbag inflators. The most recent recall is the last phase of is efforts to replace the potentially deadly Takata airbags.
